4. System Update

A. Farmworker Van Ridership Trends

Last month, Staff was invited to participate in a panel discussion with the Farm Bureau offices in Sacramento. The discussion covered the rising use of H-2A workers in the agricultural industry. With 25% of our farm labor vans carrying H-2A workers, CalVans has become a large component of the transportation aspects of the migration policy. Increased H-2A usage also trends with an increase of employer-provided vouchers. 85% of our farm labor vans receive vouchers that cover the transportation cost.

B. Cap & Trade, Low Carbon Transportation Project Allocations

The RFP process is underway for the anticipated FY16-17 and FY17-18 funds set aside for agricultural vanpools in the San Joaquin Valley. With a 25% match, CalVans anticipates to use the \$6 million awarded by the California Air Resources Board to purchase up to 150 vans in January or February of 2018. These 15-passenger GMC vans will be equipped with XL hybrid kids. Van usage outside of the San Joaquin Valley is permissible, provided the area need for vanpools has been fulfilled first.

C. Discussions with San Bernardino Council of Governments

San Bernardino Council of Governments is considering joining CalVans to replicate the recent program set-up in Riverside County. Staff has met with the council to discuss the program details.

D. Marketing and outreach efforts

Over the course of recent education efforts at the CA State Capitol, assembly members have expressed interest in attending our community events. Recently we attended a large event in Salinas, hosted by Premium Packing, where Anna Caballero, 30th District assembly member, presented certificates of recognition to five of Premium Packing's consistent drivers. The event allowed drivers to share their own experiences about the CalVans program with her. As a community and education effort, Staff will continue to invite assembly members to events we host and attend.

5. Approve Agreement with Riverside County Transportation Commission

This agreement will provide \$400 vouchers to vanpools entering or leaving Riverside County. This is similar to the agreement with WSP USA INC (Sun Line Transit grant) that provides vouchers to the *Eastern* Riverside County (Coachella Valley area).
