## **STAFF REPORT**

#### 3. Consent Items

### A. Minutes of May 12, 2016

The attached minutes from the last meeting are ready for approval, pending any changes from the members.

# B. Resolution 01-16 Authorizing submittal of AHSC Grant application

CalVans has been invited to submit a final application for \$3.3 million in AHSC (Affordable Housing and Sustainable Communities) funds. The funds will be used to purchase an additional 80 vehicles for expanding the farm worker vanpool program. The funding will be important, as it will allow us meet the demand that is expected, once everything is in place with the USDOL.

The attached resolution 01-16 authorizes the submittal of the application. Staff recommends approval of the resolution and authorization of the Chairman's signature.

# C. Resolution 02-16 Self-Help Enterprises Lindsay Village project

Staff is working with Self-Help Enterprise Staff as a co-applicant on an AHSC application for up to \$5.6 million of funding for Lindsay Village (Dinuba) and associated infrastructure improvements. The project includes a total of 49-units, transportation improvements at southeast corner of Hermosa Street and Westwood Avenue, and funding for an on-site vanpool which will be operated in partnership with California Vanpool Authority.

CalVans role as a co-applicant requires the submittal of resolution authorizing submittal of the AHSC application. Staff recommends approval of the resolution and authorization of the Chairman's signature.

# D. Resolution 03-16 Self-Help Enterprises Dinuba Village project

Staff is working with Self-Help Enterprise Staff as a co-applicant on an AHSC application that involves an application for up to \$4.7 million of funding for Sierra Village (Dinuba) and associated infrastructure improvements. The project includes a total of 44-units, transportation improvements at Davis and Crawford, and funding for an on-site vanpool which will be operated in partnership with California Vanpool Authority.

CalVans role as a co-applicant requires the submittal of resolution authorizing submittal of the AHSC application. Staff recommends approval of the resolution and authorization of the Chairman's signature.

### 4. System Update

# A. Recent USDOL meeting

As Staff mentioned at the last meeting, USDOL is working on an MOU (Memorandum of Understanding) for the purpose of allowing all individuals who transport farm workers the option to use CalVans. Presently USDOL regulations prevent those who are registered as FLCs (Farm Labor


Contractors) or those who recruit, supervise or are paid to transport form using a CalVans vehicle. The MOU is being circulated within the USDOL and may take some time before the review is completed.

Region 9 Staff would like to move forward on establishing a relationship that would open up the possibility of using CalVans sooner rather than later. To that end Staff met with USDOL Staff a second time to work out the steps or procedures to make this happen. The meeting focused on what changes CalVans may have to make and what USDOL staff is expecting as far as approval prior to issuing a van, as well as what they expect to find when conducting an inspection in the field. It was agreed that CalVans will modify its Driver agreement to reflect insurance coverage and vehicle service. The agreement now mentions the \$10 million coverage and the fact that vehicle are serviced in compliance the California Vehicle Code section covering maintenance of vanpools.

It is anticipated that everything will be in place within the next several weeks allowing any farmworker the ability to operate a CalVans vanpool without fear of violating USDOL regulations.

## B. Demand is exceeding supply

Staff is experencing a marked increase in the number of agricultural vanpools asigned, even before anything is in place with the USDOL. The number of vans assigned to farm workers now exceeds 250. This brings the the total number of vanspools assigned to over 500. The following graph shows total vans assigned by month for the past several years. Over that time the number of vanspools assigned to farm workers has grown each year. Our growth will be constrained this summer as we will be out of available vans later this month.



The overall distance traveled agricultural vanpools has also continded to grow. Last May we billed for at total of 252, 442 miles, this May it was 397,280. This is a 57% increase over last year. As the miles have grown so have the number of growers or contractors supporting the use CalVans by their employees.

Additional vehciles will secures through grants or lease/purchased, with the lease/purchase cost being passed on to growers or contractors who are providing vouchers to their employees. It is anticipted that most new vans being assigned under the USDOL MOU will be of this type.
