4. System Update

A. August Newsletter

The August newsletter was prepared as an update for the various growers and contractors that use or participate in the CalVans farmworker vanpool program. In the newsletter we are asking the employers to let us know how many vans their employees will need going into the winter months as work transitions to the Imperial/Yuma areas. The newsletter also highlights various vans and their riders at work in the field.

B. FY 16-17 Ridership Numbers

Staff has completed the sorting of all vanpool trips by both county of origination and UZA. The number of Passenger Lane Miles is up overall by 4% with the counties of Imperial and Ventura Counties showing the largest growth. This growth is driven by an increase in the number of farmworker Vanpools in these two counties. In total, we carried 2.6 million passengers while traveling 10.7 million miles, thus generating 113 million passenger lane miles. We also for the first time have data for the San Joaquin and Riverside Counties for some farmworker vanpool activity that occurred in June.

The vanpool ridership sorted by UZA shows the largest growth in Santa Barbara, Santa Maria and Imperial. This is also due to the large number of farmworker vanpools operating in the region. The UZAs of Stockton and Indio-Cathedral City have been added, as there are some trips in June that occurred in their areas. The numbers being reported to the Federal National Transit Database on behalf of the many UZAs touched by CalVans vanpools will again generate somewhere around \$10 million for the many local transit agencies. This generation of funds is the reason some agencies have joined CalVans.

C. Submittal of Support letters to Senate and Assembly offices

Staff continues to work with various State officials in an attempt to secure funding for the farmworker vanpools. We were successful in securing \$3 million in Affordable Housing and Sustainable Communities (AHSC) funds several years ago, that allowed us to purchase 80 new 15-passenger vans. Last year we worked to get \$3 million was set aside for Farmworker vanpools in the Air Quality Improvement Program Funding Plan (AQIP) for San Joaquin Valley farmworkers. These funds have the potential of adding another 60 vans to our fleet.

In anticipation of the Cap and Trade extension passing, Staff visited with a number of district offices explaining the need for Farmworker vanpool funding and the positive impact it has on farmworker transportation. The general take away from the meetings was that there was general support for funding vanpool programs but we should secure some support letters from those growers whose employees use vanpools program, as well as something from the legislative districts who benefit from the farmworker vanpool program.

Staff was able to secure signatures from approximately 30 growers and 10 signatures from the following Assembly members:

The attached two letters were submitted are in response to this suggestion and simply summarize the program benefits and the suggestion that future Cap and Trade funds be identified in the Governor's budget fund the purchase of additional vehicles for the program. Unfortunately the funding did not appear in the budget as a line item but it is understood that funding may be found in the Low Carbon Transportation Category. Staff will continue dialogue with those managing the Cap and Trade program.

5. Approve Selection of Auditing Firm

Staff sent proposals to five CPA companies of which three responded. Those responding were Brown Armstrong, Price Paige &Company, and Dedekian, George, Small & Markarian. The firms were evaluated bases on the established scoring criteria with Dedekian, George, Small & Markarian with receiving the highest score, followed by Brown Armstrong and then Price Paige &Company.

Based on the scoring Staff is recommending that the firm of Dedekian, George, Small & Markarian be selected to perform the upcoming annual audits, and that the Executive Director be authorized to sign any agreements or documents.

6. Approve Contract with WSP USA INC.

At a prior meeting, the Board approved an agreement with Sun Line transit that would have allowed vanpool riders in the Coachella area to receive monthly vouchers through a Job Access and Reverse Commute (JARC) grant that Sun Line has received. The Sun Line Board has chosen to not enter into the agreement, but to instead, have the contractor ASP USA administer the grant on Sun Line's behalf.

The attached agreement between WPS USA INC and California Vanpool Authority allows WPS USA to provide vouchers to vanpools that operate in the Coachella area. The vouchers will be \$300 per month for conventional vanpools and \$75 per week for farmworker vanpools. It follows the format of the prior agreements that CalVans has with other agencies that also provide vanpool vouchers. The agreement is a little longer than most, because of the Federal funds being used for the vouchers.

Staff is recommending the Executive Director be authorized to sign the Agreement with WSP USA INC to provide voucher funding for vanpools operating in the Coachella area.
