5-1. ACTION: Approval of FY 23/24 Budget (Page 16). Page 1 – Expenditures and Page 2 Revenues. Revenue is mostly Ag vanpools and ordering an additional 491 15 passenger vans and 72 8-passenger vans. Do we want to support only Ag? This will be a topic of discussion at the August Board Meeting in Sacramento. The current wait list if 115 vans. This request is from the Ag program.

5-2. Discussion of the Agreement for Employer Donation of Vehicles for Ag Vanpool Program (Attachment 1). David Kahn overview of General Terms. Grower donates vans to CalVans to own, receive, and facilitate vans. Grower has 1st right to vans plus repair needs to be met by them if not new. Director Johnson asked what bottleneck we faced historically? Director Landecho stated it was the ability to acquire 14 passengers/1 Driver vans (15-passenger vans). Will EV work for AG community? Converting 4 Mercedes Benz units to EV's to try them out in the fields. Vehicle miles provided is sufficient, 36 million miles in rural areas, vans need to be new. Director Nelson, what is the minimum age of vans to acquire. CalVans insures new vans and installs telematics equipment, ag implements, etc.. Per Director Landecho, maximum age of 5 years or newer. Word getting out to the community to donate vehicles in Santa Barbara County. Big interest in van donation in all regions. Director Landecho reports almost 500 units to be acquired in July under the AHSC program. Older vans in Santa Barbara due to historically less VMT or ability to recoup 100% of the revenue to operate due to the short distances travelled. Grant will provide 50 new EV's under an AHSC grant for Guadalupe. Mileage drives revenue. CalVans is accepting for donations. Chair McShane – Metering requests. Director Johnson commented "Very Illuminating" conversation on how the community can help the agency.

- 5-3. Discussion for Independent Insurance Quotes for CalVans JPA (Attachment 2). After budget review Kings County continues to be the best option for 2023-24 fiscal year to continue health coverage. Executive Committee decision to keep insurance. Retreat discussed.
- 5-4. Discussion of JPA Revisions, Bagley Keene vs. Brown Act and AB1887 (Attachment 3). Discussed Bagley Keene vs Brown Act, moving toward revising JPA through Bagley Keene Act vs. Brown Act or lobbying for exception for CalVans due to multi-regional membership. Difference: Bagley Keene provides for 10 days notice for agenda but can teleconference. Salinas Valley depends on AZ. Director Lopez asked that Director Landecho elaborate on why we need Bagley Keene. Director Landecho explained it is the counterpart to Brown Act, but Bagley Keene is for multi-regional agencies, so conducting meetings can continue Zoom without all of the restrictions of Brown Act. That is why changing JPA to Bagley Keene Act would be preferential. Director Lopez asked if CalVans is a State Agency? Director Landecho explained we are not. We will have to continue to follow current local government agency rules if we do not change to Bagley Keene. Director Lopez requested this be further researched.
